Marsch has served as a board member for the Bolivar Area Chamber of Commerce and been involved in many community projects during her tenure at the Herald-Free Press. While a student at SBU, she was editor of the university's "Mozarkian" yearbook for two years and worked for the student newspaper, "The Omnibus," for one semester.

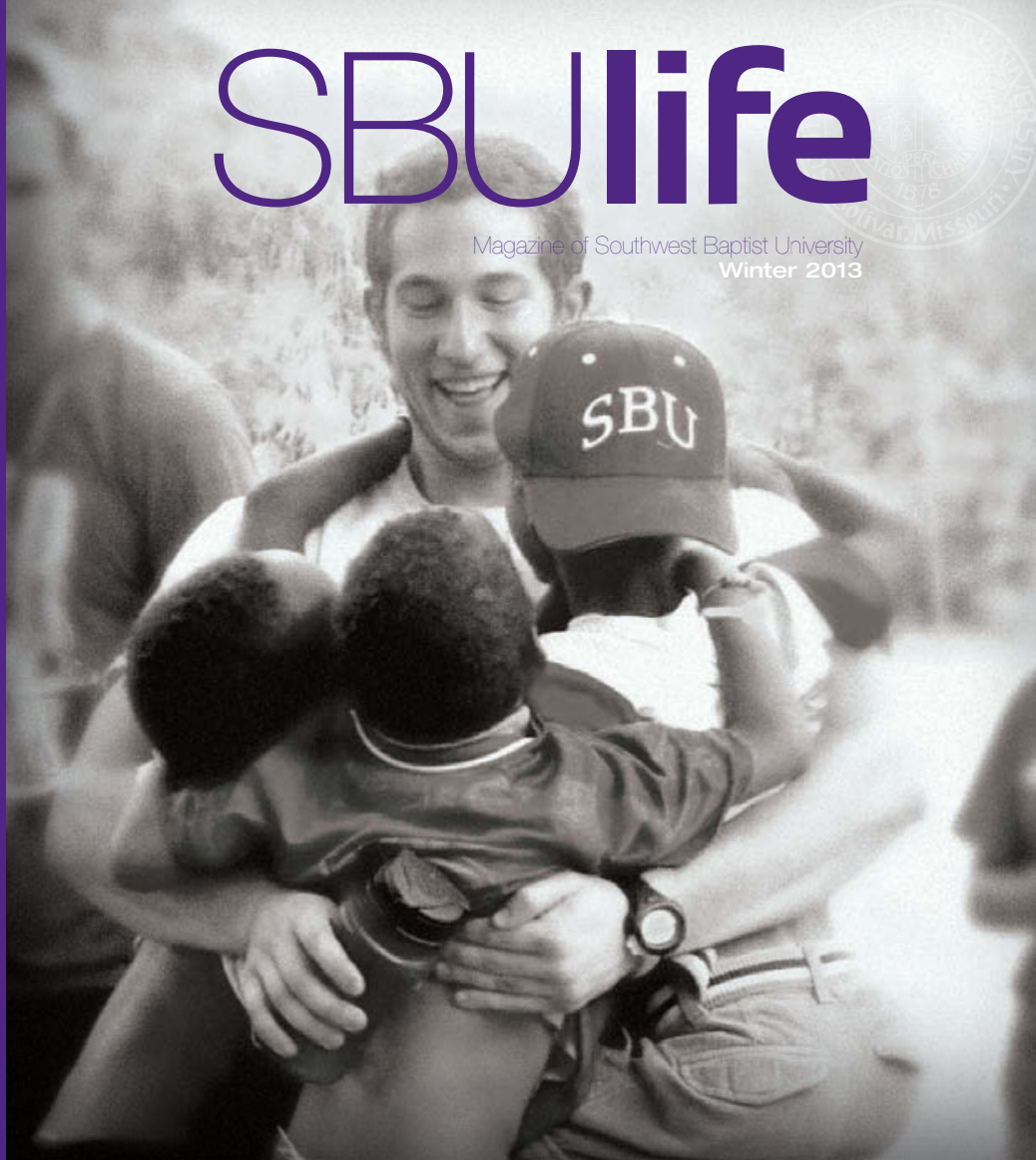

Track and Turf Campaign down to the final stretch

Mabee Foundation issues \$300,000 challenge grant

The Mabee Foundation recently issued a \$300,000 challenge grant toward the \$1.5 million Track and Turf Renovation project.

In order to receive the grant funding, the university must raise an additional \$171,000 by June 30, which will complete the project.

“We are extremely grateful to the Mabee Foundation for approving this grant to help us finish out this project,” SBU President Dr. C. Pat Taylor said. “The Mabee Foundation has been extremely generous to SBU for decades, contributing approximately \$3 million to facility projects on campus.”

Built in 1985 and named for Robert

W. Plaster, who was a major contributor to the project, SBU’s Plaster Stadium houses a football field and track. The stadium’s grass field will be replaced with a safer, all-weather synthetic turf for the football and soccer programs, as well as a state-of-the-art competition track. The stadium press box will be renovated and new lockers added to the Plaster Athletic Center. The renovations will benefit SBU students and the Bolivar community for years to come. Both the SBU and Bolivar High School varsity football teams host games on the field each fall.

The University plans to have the artificial turf installed and all the

renovations completed by the fall of 2013.

“We are indeed grateful for the generosity of the Mabee Foundation and for the many other individuals and organizations who believe in the benefit this will provide, not only to SBU, but to the Bolivar community,” said Dr. Brad Johnson, vice president for university relations. “We are fortunate to live in a community where so many people believe in SBU and its mission to serve students.”

Bethards new Dean of SBU College of Business and Computer Science



After conducting a nationwide search for a new Dean of the College of Business and Computer Science at Southwest Baptist University in Bolivar, Mo., the University is

promoting Dr. Troy Bethards, associate professor of business administration, to the Dean’s position effective June 1.

“Dr. Bethards has a tremendous breadth of knowledge and great leadership skills,” said Dr. Bill Brown, SBU provost. “He is very well respected and trusted by the faculty. He understands their goals and what’s important to each of them.”

Bethards began teaching at SBU’s Springfield campus in 2000 and transferred to the Bolivar campus in 2003. He graduated from SBU in 1993 with a bachelor of science in economics and business administration and from Missouri State University in 1996 with a master’s degree in business administration with a concentration in finance. He completed his doctorate in business administration with a concentration in finance from Anderson University in Anderson, Ind., in 2010.

A Sam Walton Fellow, Bethards has been the adviser for the SBU Enactus (formerly Students in Free Enterprise) chapter since 2007 and was named the Ruby Letsch-Roderique Chair of Economics/Finance in 2011.

He received the Orien B. Hendrex Distinguished Teacher Award, selected by graduating students during the previous four years, in 2008. Students in the College of Business and Computer Science selected him to receive the Psalm 15 Award in 2004.

“The faculty that we have here in the College of Business and Computer Science and the culture in our college, the environment in which we interact with students, are second to none,” Bethards said. “To be able to lead out in that really excites me.”

Bethards and his wife, Monica, live in Bolivar and have a daughter, Alyssa, 14, and a son, Mason, 11. They are active in Wellspring Baptist Fellowship in Bolivar.

SBU graduate education students receive honors

Three students in Southwest Baptist University's new educational doctoral program have received regional recognition for their work as principals and have been nominated for statewide awards from the Missouri Association of Elementary School Principals and Missouri Association of Secondary School Principals.



- **Chris McClimans**, principal at Osceola Elementary School in Osceola, Mo., has been selected as this year's Missouri Distinguished Principal from the Central District of the MAESP. He was a fifth-grade teacher before becoming elementary principal in Osceola 11 years ago. He is one of 12 principals from MAESP districts around the state who

will be honored March 9 at a reception and banquet at Tantara-A Resort at Osage Beach. He completed his master's and specialist degrees at SBU.

Nominees are recognized as outstanding elementary principals for their achievements and to honor the importance of the role of the elementary principal in achieving quality education. They were selected by their colleagues for achievements above and beyond those expected in a school program.



- **Shane Dublin**, principal at Bolivar Middle School in Bolivar, Mo., was named 2012-13 Middle Level Principal of the Year from the Southwest District. Dublin has served as the principal at BMS for the past seven years after serving as principal at Half Way Junior and Senior High for one year. He taught sixth-grade math and seventh-grade

Spanish for five years before that. He earned his undergraduate degree in middle school education from SBU and is a graduate of the SBU Educational Administration program.

He is one of eight finalists for the state Principal of the Year award that will be awarded in March.

The recognition is based on the principal's impact in the areas of collaborative leadership; curriculum, instruction and assessment; and personalization of the learning environment.



- **Tracy Daniels**, in her second year as principal of Bolivar Primary School in Bolivar, Mo., was chosen to represent the Southwest District of MAESP as a Missouri Exemplary New Principal and is a finalist for the state award. She completed a master's degree at SBU. She taught first and second grade for five years and was assistant principal at Bolivar

Intermediate School before becoming principal at BPS.

This recognition is given for outstanding performance in the demonstration of skills that reflect the best in educational leadership.

About the SBU Doctor of Education program

Southwest Baptist University offers a Doctor of Education (Ed.D.) in Educational Leadership specifically to prepare leaders and administrators for service in school administration and other leadership roles in various non profit or church affiliated organizations. The University's Graduate Studies in Education also offers six degree paths for a master's degree and a specialist degree in educational administration.

Making connections, training leaders

SBU's Center for Global Connections offers

unique opportunities for students

Through Southwest Baptist University's Center for Global Connections, students are ministering to multiple people groups around the world, but they can't do it without financial support from a multitude of donors.

With about 350 students having participated on 28 teams in 2012, students raised more than \$550,000 to fund those trips.

Teams begin to form during Global Connections Week, held each spring and fall for upcoming trips. Students submit an application and are interviewed before being accepted for a particular trip.

"We try to offer a variety of locations and a variety of ministries for our students," said Diana Gallamore, director of the Center for Global Connections, the department within University Ministries that is responsible for organizing and sending out student teams on "global projects."

Team leaders include University Ministries staff members, community members and students, which makes the program unique from those offered by many other universities. About 80 percent of the teams are led by students.

"We use a lot of student leadership, and we spend a lot of time developing students as leaders," said Kurt Caddy, Director of University Ministries. "They lead well. We

select them well and train them well. That is pretty significant for students to graduate having led an international team."

The Center's staff cannot personally train each individual, instead focusing on developing team leaders, who then lead much of the training for team members.

"Our training program distinguishes us from other mission groups," Caddy said. "I have gone on trips other places where I would meet the team at the airport. Here, we have a fall retreat weekend and a 13-week training session. That is pretty unique."

SBU also is one of the first campuses to provide in-depth security training for teams going into high-security areas. Other universities have since picked up the model, a practice that Caddy said is pretty common.

"There are many universities that call us when they are wanting to start or upgrade their missions program," he said. "We are a model for how this is done."

"This is one of the best mission programs in the country. It's not just how many students we send but the way we do it. We focus on quality, not quantity."

The Center will send 31 teams in 2013 with an estimated 350 participants.

Teams are sent to assist missionaries with the Southern Baptist Convention's International Mission Board and other agencies and churches.

The Center recently hosted a Missouri Baptist Disaster Relief training session for students, hoping to form a team of SBU trained responders who can be mobilized when disaster hits.

"Missouri again is leading the way in getting students involved with disaster relief," Caddy said.

The Center also is connecting with academic departments to collaborate on mission projects that will help prepare students to be missionaries in any professional field.

"We're seeing that evangelical work is changing," said Kelly Rehm, assistant director of the Center for Global Connections. "We are seeing more professionals on mission who are employed internationally and have a mission. They are living out their faith as they are working or studying."

During the training and the hands-on experiences, students learn about diversity, increase their global awareness, receive cross-cultural training, learn team-building skills during a training program that spans a semester, and further develop their spiritual formation and foundation.

"It's a department that fulfills the mission of the university," Caddy said. "We are developing leadership, and we do it in a global context."

Dear SBU donors and friends,

Today, we live in an ever-changing society, which means that Southwest Baptist University must be constantly changing, while also maintaining our Christian values.

We must consistently develop new curricula. We have to meet the needs of current students

– and those needs constantly change. We have to prepare students for future careers, some of which do not exist today. However, we must not change our core values and our mission of being a Christ-centered, caring academic community preparing students to be servant leaders in a global society.

One area that is vital to our future success is accreditation. This spring semester we will have two accreditation visits. We will have the third of four annual visits from the Council on Social Work Education for the initial accreditation of our social work program. We also will have a visiting Higher Learning Commission team to review our request to offer the master's degree in education online. If this visit is successful, then we can offer a limited number of degrees completely online.

Currently, we are fundraising for two projects. The project that is time sensitive is the track and turf project for synthetic turf for the football field and a new track. We are close to meeting our goal of \$1.5 million, and I would like to complete the fundraising by the end of April, giving the contractors plenty of time to complete the project before the beginning of the 2013 football season. We are almost half way to our goal of \$250,000 for the Roy Blunt Chair of History.

One of the goals in our new strategic plan is to increase the endowment to \$30 million during the next few years. Fundraising for the endowment is a continuous process, and when we reach \$30 million we will set a new goal.

We continue to develop new and exciting curricula. We continue to have successful accreditation visits and reports. We continue to have success in fundraising. SBU is blessed with good enrollment and outstanding alumni. These are great days for our University.

However, with all of these successes, we continue to face challenges. Sometimes our challenges seem daunting, but I know by the grace of God, we will succeed.

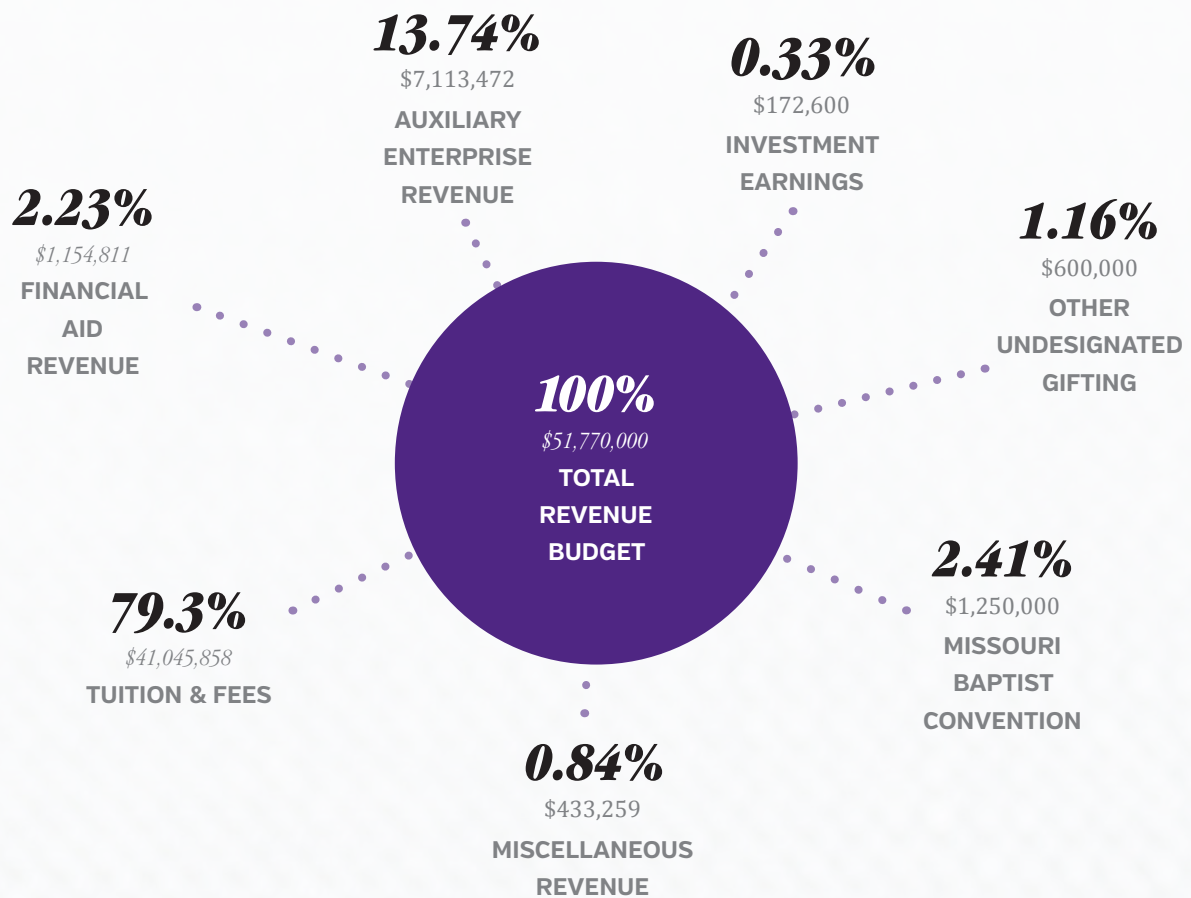

Jeff Christopherson: Leading NAMB transformation in Canada, northeast U.S.

Jeff Christopherson '86 is helping the Southern Baptist Convention's North American Mission Board overhaul its approach to missions work in North America, and every day he utilizes skills learned while a student at SBU.

Christopherson majored in religious studies and communication arts with a minor in philosophy. He grew up in Canada and knew he wanted to pursue missions as a career, but he thought all missionaries had to be preachers.

"I was totally afraid," he said. "I knew God was calling me to bring the good news to Canada, but I was terrified to speak in front of a class."

He started overcoming that fear when he was thrust into speaking while on a revival team organized by Don Baker, and classroom experiences further developed his communication and leadership skills.

"Three professors had a big impact on my life trajectory," he said. "Bob Derryberry taught me how to communicate, Mark Tappmeyer taught me how to write and Dan Cochran taught me how to think outside the box."

Christopherson is now vice president for Canada and Northeast U.S. for NAMB.

"We're overhauling the North American Mission Board to really focus on reaching the large populations in North American who have little access to the gospel," he said. "Our resources were in areas where there was large access to the gospel. We're changing the culture of the North American Mission Board."

Christopherson also has written a book, "Kingdom Matrix," that was released in August and is about how to design a church for the kingdom of God. Proceeds of sales are going to church planters.

He lives in Toronto, Canada, with his wife, Laura Elkins '87, and their two children.

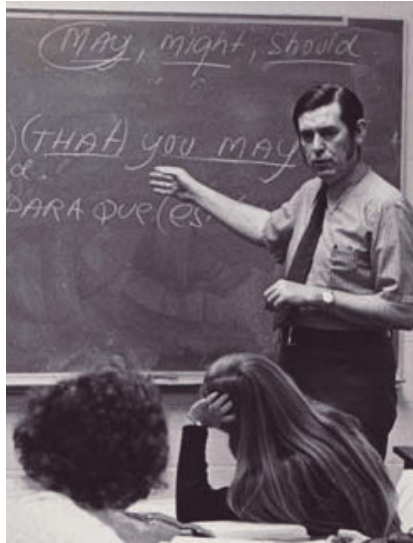
